Effective from 6<sup>th</sup> November 1991

### **SCOPE OF TARIFF**

This tariff applies to performances of copyright music within IMRO's repertoire in bars, lounges, cabaret rooms and similar premises but does not apply to such premises when they form part of a hotel, disco or restaurant.

### **ROYALTY RATES**

The following charges apply to all royalties falling due between

When music is provided by any combination of (i), (ii) or (iii) above, a discount of 20% from the total charge under Section C will apply

**REBATE**

A rebate of 33.33% will be allowable from the first year rates, where a music user obtains a licence before any music is performed.

**INFLATION ADJUSTMENT**

The foregoing rates of charge are related to the Consumer Price Index of Retail Prices for mid August 2009 (on the November 1982 base) as published in the Irish Statistical Bulletin, ("the basic Index Figure") and will be adjusted on 6<sup>th</sup> November 2010 and each subsequent anniversary of that date in proportion to the changes in the Index.

**GENERAL CONDITIONS**

This tariff is subject to IMRO's General Conditions Applicable to Tariffs and Licences, a copy of which is available on request.

**DEFINITIONS**

**"area"** means the floor area measured from wall to wall of the whole of that part of the premises to which the public is admitted and in which the music is audible.

**"background music"** means music when performed by a record/tape/cd player otherwise than for featured purposes, and includes music performed by a radio or television set operated on the premises, whether or not diffused through a loudspeaker from another part of the premises or a source outside the premises.

**"featured music"** means music performed by:-

- (i) performers, or
- (ii) a record/tape/cd player primarily for entertainment or dancing whether by means of discotheque equipment or otherwise.

**MINIMUM ROYALTY**

The minimum annual royalty under this tariff is €85.72. (Except in the case of performances by means of a Television set only – 26" or less).

**VALUE ADDED TAX**

Each licensee under this tariff shall pay to IMRO, in addition to the royalty due under the tariff, a sum in respect of Value Added Tax calculated at the relevant rate on the royalty payable

**PREVIOUS TARIFFS**

All previous editions of this tariff are withdrawn as and from the 5<sup>th</sup> November 2009.
